ORDER

Whereas, a War Room meeting was held on 16.04.2021 for reviewing the current situation of COVID-19 cases in U.T., Chandigarh. In the said meeting, it was decided that the District Magistrate, Chandigarh shall issue an order of Weekend Lockdown to be effective from Friday 16th April, 2021 10:00 P.M. to Monday 19th April, 2021 05:00 A.M.

Whereas, an order no. DM/MA/2021/7380, dated: 07.04.2021 and order no. DM/MA/2021/8080, dated: 13.04.2021 was issued by the undersigned wherein night curfew was imposed in Chandigarh from 10:00 P.M. to 05:00 A.M.

Now, therefore, I, Mandip Singh Brar, I.A.S., District Magistrate, U.T., Chandigarh, in continuation of the above mentioned orders while exercising the power vested with me u/s 144 Cr.P.C. do hereby order that there shall be a weekend lockdown from Friday 16th April, 2021 10:00 P.M. to Monday 19th April, 2021 05:00 A.M. in U.T., Chandigarh. No person shall leave their homes or shall move on foot or by vehicle or travel or stand or roam around on any road or public places during above said hours.

Following categories shall be exempted:

- Those tasked with law & order/emergency and municipal services/duties including Executive Magistrates, Police personnel, Military/C.A.P.F. personnel in uniform, health, electricity, fire, media persons with accreditation and Government machinery tasked with COVID-19 related duties (all on production of Identity Card).
- Essential Commodity shops and vendors dealing with food, groceries, fruits & vegetable, dairy & milk booths, meat & fish, animal fodder, pharmaceuticals and medical equipments shall be allowed to open for Home Delivery only.
- Manufacturing units of essential commodities shall be allowed to remain open.
- 4. Those specially issued a restricted movement curfew pass by the officers authorized in this behalf.
- 5. There shall be no curbs on inter-State and intra-State movement of essential and non essential goods.

- 6. All vehicles/persons in bonafide transit (inter-State/intra-State) shall be allowed to pass, but only after due verification of point of origin and destination.
- 7. Hospitals, chemist shops and A.T.M.s shall be allowed to remain open 24X7.
- 8. Pregnant women and patients for getting medical/health services.
- 9. Passengers going to or returning from the airport or railway station or I.S.B.T. shall be exempted.
- 10. During weekend curfew period, the restaurants/eating places, hotels including food joints/courts in various malls can remain open only for home delivery up to 09:30 PM. The restaurant and Home delivery staff shall be allowed to move on production of valid I.D. card issued to them by their respective establishment.
- 11. All Govt. employees called for essential duty during lockdown shall be allowed transit on production of valid identity card issued by there respective governments.
- 12. All marriage functions which have taken permission from the concerned SDM shall be allowed subject to the limit of 100 people outdoor or 50 indoor or 50% of the total capacity whichever is lesser.
- '13. The marriage organisers or other persons seeking movement pass may contact on 0172-2700076 & 0172-2700341 or apply online on www.admser.chd.nic.ln/dpc for a movement pass. Sh. Pardhuman, HCS and Sh. Sanjeev Kohli, RLO will be the Nodal Officers for this purpose.
 - 14. During the weekend curfew period, those going for appearing in examination and those on examination duties will be allowed movement on production of admit/identity cards.
 - 15. All vaccination centres / testing centres / dispensaries / medical facilities will remain open during curfew.



16. All passes related to the Hon'ble Punjab and Haryana High Court and District Court shall be issued by the Registrar General, Punjab & Haryana High Court.

Any breach of this order shall invite action under section 188 of the Indian Penal Code.

This order shall come into force with immediate effect.

In view of the emergent nature of the order, it is being issued ex-parte and is addressed to the public in general.

This order shall be promulgated by affixing copies thereof at the notice boards of the office of the undersigned as well as District Courts and publication in the newspapers having circulation in the area, through the office of the D.P.R., Chandigarh.

ORDER

Whereas, vide order no. 40-3/2020-DM-I(A), dated: 23.03.2021, the Union Home Secretary, Ministry of Home Affairs, Govt. of India had issued an order u/s 10(2)(1) of the Disaster Management Act, stipulating the guidelines for effective control of COVID-19 in the country up-to 30.04.2021.

Whereas, situation of COVID-19 in U.T., Chandigarh has been reviewed in War Room meeting held on 16.04.2021 and it has been observed that there has been a sharp increase in COVID-19 cases during last few days.

Now, therefore, the undersigned in exercise of the power conferred u/s 22 of the Disaster Management Act, 2005, in his capacity as Chairperson, State Executive Committee, State Disaster Management Authority hereby issues the following directions:

- 1. There will be a weekend lockdown starting from 10:00 P.M. on 16.04.2021 (Friday) till 05:00 A.M. on 19.04.2021 (Monday). The residents must stay indoors during the lockdown period. Only essential activities will be allowed. During the weekend lockdown period, those going for appearing in examination and those on examination duties will be allowed movement on production of admit/identity cards. Also, during the weekend lockdown, home delivery of food will be allowed. All vaccination centres/testing centres/dispensaries/medical facilities will remain functional during lockdown and people will be allowed to travel during lockdown, for vaccination/testing, etc. Detailed order shall be issued by the District Magistrate, Chandigarh.
- 2. All gymnasiums and spas will remain closed till 30.04.2021.
- 3. The cinema halls can run with 50% capacity till further orders.
- 4. All Government offices will function with 50% of their staff. Further, as per the guidelines of Govt. of India, all officers of the level of the Deputy Secretary, equivalent and above shall attend office on regular basis. Head of the Departments shall prepare roster for the attendance of the staff concerned.

- 5. Visitors will be allowed to meet officials only with prior appointments.
- 6. There will be a ban on social, cultural, political & religious events, etc. till further orders.
- 7. The existing limit of gatherings in permitted functions will be reduced to 100 (outdoor) and 50 (indoor) or 50% of the total capacity, whichever is less.
- 8. The Transport buses will run with 50% capacity only.
- 9. The Museums, libraries, coaching institutions, etc. will remain closed. However, the online coaching will be permitted.
- 10. There will be screening of all visitors to the city at airport, railway station, ISBT, etc.
- 11. Directions in regard to District Courts-43, Chandigarh and High Court shall be passed by the Hon'ble Punjab & Haryana High Court.

Any breach of this order shall invite action under section 51 to 60 of the Disaster Management Act, 2005 and section 188 of the Indian Penal Code along with other applicable laws.

This order shall come into force with effect from 10:00 P.M. on 16.04.2021 and shall remain in force till 30.04.2021.

In view of the emergent nature of the order, it is being issued ex-parte and is addressed to the public in general.

This order shall be promulgated by affixing copies thereof at the notice boards of the office of the undersigned as well as District Courts and publication in the newspapers having circulation in the area, through the office of the D.P.R., Chandigarh.
