Industries and Commerce Department - Imposing of in the State from 05-04-2021 for two weeks to contain the spread of Covid-19 - Guidelines for operating Industries in the State following Standard Operating Procedures (SOPs) - Orders - Regarding

#### ORDER:

Through the ref read, the Government have issued orders imposing curfew in the State to contain the spread of Covid-19 and issued regulations which shall come into effect immediately and remain in force for two weeks starting from 5th May 2021 where the District Collectors & Magistrates of the State shall impose regulations under Section 144 of Cr PC in prohibiting the gathering of public not more than five even in permitted hours of movement.

- 2. As per the para 3(h) all manufacturing industries shall be permitted to operate duly following Covid appropriate protocol SOPs and as per the Guidelines issued by the Industries Department.
- 3. Accordingly, the Government after careful examination of the matter and compliance of the above hereby issued the following guidelines for operating Industries in the State for two weeks starting from 5th May 2021 beyond the curfew hours.
  - i. All Essential and Continuous process industries are permitted to operate 24x7 as per the list in the Annexure.
  - ii. All other industries are permitted to operate in single sift /2 shift based on the need of the Industry. All units, take steps to optimize the number of shifts to contain the COVID and to complete the operations by 2.00 PM

- iii. The industries which are under construction are permitted to continue their construction in a single sift.
- iv. All national infrastructure/pipeline projects which are under construction stage are allowed to continue their works
- v. All the above industries/activities shall submit self-certification indicating the employees proposed to work in the industry beyond the curfew hours with photographs to the General Manager, DIC, and the concerned MRO and Police
- vi. The industry shall take the responsibility of issuing identity cards to their employees as per the list furnished to GM/DIC and the local authorities
- vii. Based on the ID cards, movement of the workers and the vehicles will be allowed beyond the curfew hours
- viii. Containers, Trucks carrying goods shall be allowed to move freely based on relevant documents to load and unload materials.
- ix. A team shall be constituted at DIC with an officer from DIC, Factories, Labour Department, and one/two representatives of the Industrial Associations to monitor and resolve the issues, if any. The contact numbers of the officers of the team shall be notified to all the Industries in their District.
- 4. No separate/ fresh permissions will be required from any authority for operating the above activities, but with a self-certification given by the head of the industrial unit. S(he) will self-certify to run the unit by complying with all the Standard Operating Procedures (SOPs) concerning social distancing and other measures for containing the spread of COVID-19 as prescribed by MHA from time to time, without any relaxation whatsoever in this regard. Any violations in terms of the self-certification or implementation of the SOPs shall result in prosecution under Sections 51 to 60 of the Disaster Management Act, 2005 and Section 188 of IPC as well as other applicable laws.
- 5. Therefore, the District Collectors in the State of AP/ All the Superintendent of Police in the State of AP/ Director of Factories, Andhra Pradesh, Vijayawada /Commissioner of Labour, Andhra Pradesh, Vijayawada Commissioner of Transport, Andhra Pradesh, Vijayawada and Director of Industries, Andhra Pradesh, Vijayawada are hereby instructed to strictly implement the guidelines accordingly.

- 2. Continuous process Industries:
  - a. Petroleum Refineries

  - g. Float Glass Plants

  - c. Maintenance and operations of data centres and other critical IT infrastructure needed to support backend operations of medical, financial, transport and other critical services.
  - d. Warehousing activities including loading, unloading and storage of goods.
  - e. In the case of other industries that are not exempted, essential maintenance needed for the purposes of fire safety, machine safety and worker safety shall be permitted during Sundays.

## **HEALTH, MEDICAL AND FAMILY WELFARE (B2) DEPARTMENT**

G.O.RT.No. 192

Dated: 04-05-2021. Read the following:

#### ORDER:

Government of Andhra Pradesh has taken several steps to contain the spread of Covid-19 with focus on test-trace- treat-vaccinate and inculcating COVID appropriate behaviour among people of Andhra Pradesh.

- **2.** While reviewing the status of covid pandemic situation in the state and in the wake of surge in cases reported in the last one month, Government after examination, hereby impose the curfew from 12 Noon to 6 AM with effect from 05.05.2021 for a period of two weeks (05.05.2021 to 18.05.2021).
- **3.** During the period of implementation of the curfew, all firms, shops, establishments, offices, educational institutions, restaurants etc. shall close at 12 Noon and reopen after 6 AM except hospitals, diagnostic labs, pharmacies and those dealing with supply of essential services such as the following:
  - **a.** Print and electronic media.
  - **b.** Telecommunications, Internet services, Broadcasting services, IT and IT enabled services.
  - c. Petrol pumps, LPG, CNG, Petroleum and Gas outlets.
  - **d.** Power Generation, Transmission and Distribution.
  - e. Water supply and Sanitation.
  - **f.** Cold storage and warehousing services.
  - **g.** Private Security Services.
  - **h.** All manufacturing industries shall operate duly following covid appropriate protocol SOPs which shall be issued by the Industries Department.
  - i. All agricultural operations including procurement of agricultural produce shall be allowed duly following covid protocol which shall be issued by the Agriculture Department.
- **4.** Movement of all persons shall be prohibited from 12.00 Noon to 6 AM except the following categories of persons:
  - **a.** Persons engaged in the activities listed in Para 3 above.
  - **b.** Officers/Officials of Government of India and Government of Andhra Pradesh including those of High Court of A.P. and other courts, Urban Local Bodies and Panchayat Raj Institutions on emergency duty on production of valid duty pass with identity card.

- **c.** All Medical personnel such as Doctors, nursing staff, paramedics and providers of other Hospital services (both Govt. and Private) etc. on production of valid identity card.
- **d.** Pregnant women and patients for the purpose of receiving medical care.
- e. Persons availing covid vaccination in designated health facilities.
- **f.** Persons availing health care in public or private health care establishments.
- **g.** Transportation of persons in private vehicles for availing health care services.
- **h.** Persons coming from/going to airports, railway stations, bus stands on production of valid ticket. The local administration shall make appropriate arrangements at the airports and railway stations to enable such travel.
- i. All Inter-State and Intra-State movement of essential and non-essential goods are permitted.
- **j**. Local transport services including autos and taxis and city bus services shall be allowed to function within the stipulated time (6AM to 12 Noon) duly following all covid protocols communicated from time to time.
- **k**. Intra and inter district public transport shall not be allowed. Inter state public transport shall also remain suspended from 12 Noon to 6 AM.
- I. Functions like marriages etc., which are already scheduled and can not be rescheduled shall be carried out with a maximum of 20 persons with due permission from the local authorities, duly following covid appropriate behaviour.
- **5.** All Departments of the Secretariat/Commissioners of Police/District Collectors shall issue consequential orders/ notifications to implement the above instructions. They shall also make arrangements to issue passes to the exempted category of persons to facilitate their movement.
- **6.** The above regulations shall come into effect immediately and remain in force for two weeks starting from 5th May, 2021.
- **7.** The District Collectors & Magistrates of the State shall impose regulations under Section 144 of Cr PC in prohibiting the gathering of public not more than five even in permitted hours of movement. This shall not be applicable for people standing in queues following social distance norms for purchasing goods and services. However, the exemptions specified in Para-3 shall be applicable throughout the day.
- **8.** Any violation of the aforesaid instructions, shall result in prosecution under Sections 51 to 60 of Disaster Management Act, 2005 and Section 188 of IPC as well as other applicable laws.
- **9.** The Collectors & District Magistrates and District Superintendents of Police and Commissioners of Police shall enforce these orders in the State scrupulously.
