ORDER

(Under Section 144 of Criminal Procedure Code, 1973)

The Ministry of Home Affairs (MHA), Government of India vide order No. 40-3/2020-DM-I(A), dated 23.03.2021 and Delhi Disaster Management Authority (DDMA), Government of NCT of Delhi vide order No. F.2/07/2020/pt. file-III/457, dated 24.07.2021 has issued directions and guidelines for effective control of Covid-19.

Now, therefore, in exercise of powers conferred upon me by Section 144 of the Criminal Procedure Code 1973 (No.2 of 1974) read with Government of India, Ministry of Home Affairs, New Delhi notification No. U-11036/3/1978(I) UTL dated 01.07.1978, I, Sanjay Sharma, Asstt. Commissioner of Police, Sub-Division Rajouri Garden, West District, Delhi promulgate the wearing of face mask, maintaining social distancing etc. at public places, workplaces, during transport, all shops which are providing essential goods & services such as grocery shops, medical shops, fruits & vegetable shops, road side vendors is mandatory for all people/shopkeepers/customers. And further promulgate the following orders for maintaining public health, public safety and public order in the jurisdiction of Sub-Division Rajouri Gardem, West District, Delhi comprising PSs Rajouri Garden, Hari Nagar & Janak Puri.

The following activities shall be permitted with restrictions as specified below from 05:00 AM dated 26.07.2021 (Monday) to 05:00 AM dated 09.08.2021 (Monday) in Sub Division, Rajouri Garden. No permission is required from any authority for undertaking the following permitted activities:

- (i) All Standalone (single) shops and all Neighborhood (colony) shops and shops in residential complexes, shall be permitted to open on all days without any distinction of essential and non essential goods/services. However, the timings of such shops dealing with non-essential goods/services will be between 10:00 AM to 8:00 PM.
- (ii) All Markets, Market complexes and Malls shall be permitted to open between 10:00 AM to 8:00 PM.
- (iii) Restaurants are allowed up to 50% of the seating capacity from 8:00 AM to 10:00 PM.
- (iv) Bars are allowed up to 50 % of the seating capacity from 12:00 Noon to 10:00 PM.

The owners of restaurants and Bars shall be responsible for strict adherence to the prescribed SOP and all instructions/guidelines issued by Gol/GNCTD from time to time as well as compliance of COVID Appropriate Behavior (viz. wearing of masks, maintaining social distancing, regular hand

washing and use of sanitizer etc.) to contain the spread of COVID-19 virus. In case, any violation is found, strict penal/criminal action shall be taken against the owner of the restaurant and Bars.

- (v) Cinemas/Theaters/Multiplexes are allowed up to 50% of the seating capacity.
- (vi) Auditoriums/Assembly Halls are allowed up to 50% of the seating capacity.
- (vii) Business to Business (B2B) exhibitions will be allowed only for business visitors.
- (viii) Transportation by Delhi Metro shall be allowed up to 100 % of the seating capacity of metro coach. No standing passenger shall be allowed.
- (ix) Transportation by buses: Intra-State (within NCT of Delhi) movement of buses (DTC as well as Cluster) shall be permitted with the condition that not more than 100 % of seating capacity. In the case of buses, boarding shall be allowed only from the rear door while de-boarding shall be allowed only from the front door. No standing passenger shall be allowed.
- Public transport such as Autos & e-rickshaws (up to 2 passengers) / Taxis, Cabs. Gramin Sewa & Phat Phat Sewa (up to 2 passengers)/Maxi cab (up to 5 passengers), RTV (up to 11 passengers) shall be allowed.
- (xi) Funeral/last rites related gatherings are allowed up to 100 persons.
- (xii) Marriage related gatherings shall be permitted with a ceiling of 100 persons.
 - The owner of banquet halls/marriage halls/hotels etc. shall be responsible for ensuring strict compliance of COVID Appropriate Behavior (viz. Wearing of masks, maintaining social distancing, regular hand washing and use of sanitizer etc.) to contain the spread of COVID-19 virus. In case, any violation is found, strict penal/criminal action shall be taken against the owners of the premises as well as against the individual and the premises shall be sealed forthwith.
- (xiii) Religious places shall be permitted to open, but no visitors will be allowed.
- (xiv) Stadium/Sports complexes will be permitted to open without spectators, subject to strict compliance of SOP dated 29.01.2021 issued by Govt. of India and other instructions/guidelines issued by GOI/GNCTD from time to time as well as strict adherence of COVID Appropriate Behavior (viz. wearing of masks, maintaining

social distancing, regular hand washing and use of sanitizer etc.) to contain the spread of COVID-19 virus.

- (xv) Spas will be permitted to open subject to following conditions/restrictions:
 - a) There shall be strict compliance of the conditions specified in the Office Memorandum dated 18th November, 2020 of MoH&FW in respect of Spas. Six (6) feet distance shall be in general maintained between clients and employees. Insofar as the service providers i.e. therapists etc. are concerned; they shall maintain all standards of hygiene, masking etc. as set out below.
 - b) In addition, considering the nature of services provided in Spas, all employees in such establishments shall undergo two dose of COVID-19 vaccination or fortnightly RTPCR test, especially the therapists who are likely to come in close contact with clients.
 - c) All therapists and other employees, as also the visitors, shall be subjected to thermal temperature checks and if anyone shows any symptoms, they would not be permitted entry in the establishment.
 - d) All service providers shall wear face shields and masks while providing therapy. For treatments which are longer than 30 minutes, a PPE kit should also be worn in addition.
 - e) Clients should preferably wear masks to the extent possible, considering 5the nature of services which are availed of.
 - f) All visitors/clients shall sign a declaration from to the effect that they have not contracted COVID-19 and if they have, they have tested negative. The establishments are permitted to take a written consent from accepting the risks that may be involved for clients/visitors.
 - g) Tools including clothing, other apparel towels etc. used for clients shall be sanitized after each and every treatment.
 - h) It shall be ensured that hygienic conditions are maintained in the spas and other safeguards in force for salons shall also be adhered to by the spas.

The owners of Spas shall be responsible for ensuring strict compliance of aforesaid conditions as well as COVID appropriate behaviour (viz. wearing of masks, maintaining social distancing, regular hand washing and use of sanitizer etc.) to contain the spread of COVI-19 virus. In case, any violation is found, strict penal/criminal action shall be taken against the owner of the Spa as well as against the individual and the premises shall be closed forthwith.

(xvi) Only one authorized weekly market (up to the limit of 50% of the allowed vendors at normal time) per day per zone in all three Municipal Corporations/New Delhi Municipal Council/Delhi Containment Board shall be allowed subject to the strict

compliance of SOP (already circulated) and all instructions /guidelines issued by Gol/GNCTD from time to time to contain the spread of COVID-19. Weekly market shall be selected by the Zonal Dy. Commissioner of Municipal Body as per prescribed guidelines for selection of weekly market issued on dated 10.09.20 (already circulated) and the information shall be shared with the respective district Magistrate and Deputy Commissioner of Police for effective implementation. No weekly market shall be allowed to function on roadsides. The weekly markets can be allowed to function at suitable nearby where grounds, grounds/school SOP/guidelines of DDMA can be strictly implemented. unauthorized weekly market shall be allowed to function. If in case it is found that COVID Appropriate Behaviour of prescribed SOPs/Guidelines are not being followed in weekly markets and /or the positivity rate, number of Covid-19 positive persons, growth rate etc. start increasing in NCT of Delhi then all weekly Markets shall be closed forthwith by Distt. Magistrate/Zonal Deputy Commissioner of Municipal Body without and loss of time so as to completely avoid and prevent and upsurge and likelihood of next wave in NCT of Delhi.

RT-PCR test of vendor/ customers of weekly markets shall be conducted on random basis by the District Magistrate concerned regularly. In case of positive test report, action should be taken as per the protocol prescribed by the Health Department, GNCTD with regard to quarantine, contact tracing, treatment etc. The lis of authorized weekly market shall be published on official website by concerned Municipal Corporation.

- 1. All other activities will be permitted, except those which are specifically prohibited/restricted. However, in Containment Zones, only essential activities shall be allowed.
- 2. There shall be no restriction on inter-state and intra-state movement of persons and goods including those for Cross-land border trade under Treaties with neighboring countries. No separate permission/approval/e-pass will be required for such movements.
- 3. In the containment zones, all measures shall be taken strictly as prescribed by MoHFW, Gol as well as H & FW Department, GNCTD, in letter & spirit by all authorities concerned.
- 4. The permitted/restricted activities shall be allowed subject to strict compliance of SoPs issued by GoI and GNCTD from time to time.

- 5. The following activities are prohibited in Sub Division, Rajouri Garden from 05:00 AM dated 26.07.2021 (Monday) to 05:00 AM dated 09.08.2021 (Monday):
 - i) All Schools, Colleges, Educational/coaching institutions etc. will remain closed Online/distance learning shall continue to permitted and should be encouraged.

ii) All social/political/sports/entertainment/cultural/religious/festival related and other gathering and congregations.

- Banquet halls (except for marriages as per condition prescribed in iii) point No. xii.
- 6. That all COVID Appropriate Behavior viz. wearing of masks maintaining social distancing, regular hand washing and use of sanitizer maintaining health hygiene, no spitting etc, in all shops, Malls, Markets, Market complexes, weekly markets, Restaurants & Bars, Mandis, ISBTs, Railway platforms/stations, public parks & gardens, Gymnasiums and yoga Institutes, banquet halls/marriage halls, Stadia, Sports complexes slum areas as well as at all area identified as hotspots for transportation of COVID-19 virus. It should be ensured that the people who visit these places strictly follow COVID Appropriate Behavior and are wearing of masks, maintaining social distancing etc. without fail. If the aforesaid norms of COVID Appropriate Behavior are not maintained by any premises/weekly markets, establishment/business premises/weekly markets shall be liable to be closed for containing the spread of CIVID-19 virus and the defaulter shall be liable for criminal prosecution under the relevant laws.
 - 7. That the Market Trade Associations (MTAs) Banquet halls/Marriage halls Associations, and Resident Welfare Associations, Gymnasiums and yoga Institutes Associations, Resident Welfare Associations (RWAs) shall also be responsible for ensuring compliance of COVID Appropriate Behaviour by all shops, Malls, Markets, Market complexes, offices, weekly markets, restaurants and Bars, public parks & gardens, Gymnasiums and yoga Institutes, banquet halls/marriage halls and residents within their respective areas. If the aforesaid norms of COVID Appropriate Behaviour are not found maintained by the persons, owners shall also be liable for criminal prosecution under the relevant laws, including closure of such establishment/business premises/weekly markets/public parks gardens.

This order shall come into force from 05:00 AM dated 26.07.2021 (Monday) to 05:00 AM dated 09.08.2021 (Monday) or further orders, whichever is earlier.

Any person contravening this order shall be punishable u/s 188 of Indian Penal Code.

As the notice cannot be served individually on all concerned, the order is, hereby, passed ex-parte. It shall be published for the information of public through press and affixing copies on the Notice Boards of the offices of all DCsP, Addl. DCsP, ACsP, all Police Stations and offices of the New Delhi Municipal Corporation, North Delhi Municipal Corporation, East Delhi Municipal Corporation, South Delhi Municipal Corporation, Public Works Department, Delhi Development Authority and Delhi Cantonment Board.
