**ORDER**

In continuation to Order No. POL.75/2020/Pt.I/112 dated 27-08-2021, the following additional activities are permitted in the State with effect from 6<sup>th</sup> September, 2021:

1. Dorbar shnong meetings, trainings, official and private programmes are permitted with prior permission from the Deputy Commissioner / SDO (Civil) and subject to attendance of not more than 1/3<sup>rd</sup> of the total capacity of the hall/venue.
2. Private transport may ply upto 100% based on local situation and as per regulation of the Deputy Commissioners / SDO (Civil).
3. Skill training programmes (both government and private) may resume subject to compliance with the SOP issued by the Ministry of Skill Development & Entrepreneurship vide F.No.B-12011/01/2016-SDE (Part I), dated 11<sup>th</sup> June, 2020 and prior permission from the Deputy Commissioner / SDO (Civil).

Further, in partial modification to Order No. POL.75/2020/Pt.I/108, dated 13-08-2021 in respect of the SoP on Preventive Measures to Contain Spread of COVID-19 in Religious Places/Places of worship, the permitted number of attendees for ordinary / regular services is revised as follows:

1. In Churches, maximum number of persons allowed during church service should not exceed 50% of the seating capacity of the church.
2. Similarly, In Temples, Mosques, Gurudwaras and other places of worship the number of persons should not exceed 50% of the seating capacity of the place of worship.

Individuals must strictly maintain a minimum distance of 5 feet.
