NOTIFICATION

Aizawl the, 5th November, 2021

No.B.13016/42/2020-UD&PA: As provided under Rule 4 of Plastic Waste (Management & Handling) Rules, 2016 as amended in 2021, manufacturing, stocking, selling, use of any carry bag (having handle or non-handle) and sheet for packing/ wrapping commodity having less than 75 micron thickness plastic materials and the manufacture, import, stocking, distribution, sale and use of following single use plastic, including polystyrene and expanded polystyrene, commodities is hereby prohibited with immediate effect:-

- i) ear buds with plastic sticks, plastic sticks for balloons, plastic flags, candy sticks, ice-cream sticks, polystyrene [Thermocol] for decoration;
- ii) plates, cups, glasses, cutlery such as forks, spoons, knives, straw, trays, wrapping orpacking films around sweet boxes, invitation cards, and cigarette packets, plastic orPVC banners less than 100 micron, stirrers

Penalty for contravention of the provisions of these Rules are imprisonment for a term which may extend to five years or with fine which may extend to one lakh rupees or with, and in case the failure or contravention continues, with additional fine which may extend to five thousand rupees for every day during such failure or contravention continues after the conviction for the first such failure or contravention (Section 15 of Environment (Protection) Act, 1986).

This Notification supersedes this Department's earlier Notification issued vide No. B. 13017/32/2014-UD&PA Dt. 25.06.2018.
